Where necessary to make the clauses applicable to this Subcontract, the terms "Contractor" shall mean "Subcontractor," "Contracting Officer" shall mean "Draper" and the "Government" shall mean "Draper" or the "Government" whenever appearing in a clause, except where specifically noted under any particular clause that the rights contained in the clause shall flow only to the U.S. Government.
